- 4) Ensure the product has all the goods (as supplied by us), and is in the original packaging or restocking fee's may be applied.
- 5) Pack the item(s) in **OUTER PACKAGING** (so the return item's retail packaging is unmarked) securely and send it with this form, to the return address.
- 6) **Please mark your PR number clearly on the outside of the parcel.**
- 7) **FAULTY ITEMS WILL BE REPAIRED OR REPLACED (provided that they meet their warranty conditions).**

Notes and Declaration

The buyer has the right to a fourteen-day cooling off period, commencing the day after goods are received, in which to cancel their order for whatever reason. Should the customer choose to exercise these rights they must return any goods supplied to them. Before goods are returned, you must contact us to obtain a Goods Return Authorisation Number. No goods will be accepted unless an authorisation number has been issued by Uheat. Your money will be refunded (by the same method as payment), less the initial delivery costs*, within 30 days of cancellation. You are responsible for the returning of the goods to us. After 15 days of delivery, a handling charge of 15% will be applied for the returning of unused goods. After 30 days of delivery, a handling charge of 25% will be applied for the returning of unused goods. No refunds will be permitted for goods returned which are not returned in the original undamaged packaging and in perfect/ re sellable condition complete with all manuals & accessories supplied with the original kits. Should goods be returned without the security seals intact, the goods will be subject to a re-testing procedure and the buyer will be advised of the associated charge. * Delivery costs are calculated at £8.51 ex vat for the 1st 10Kg and £0.45 ex VAT for every 1Kg in excess of the 10Kg.
